## TRANSPORTATION FUNDING

The Long-Range Transportation Plan (LRTP) spans 25 years, beginning in 2024 and continuing through 2050, with a funding plan of \$4,323,562,019. However, that regional funding is supplemented by \$525,583,765 in state and federal grant money, and money specifically targeted for the interstate system. That brings the total funding projected to flow into the Lehigh Valley by 2050 to \$4,849,145,784.

• • • •

The LRTP is **not** a defined budget, but rather a long-term funding plan of how to spend money that is projected to be available in those future years. It is "fiscally constrained", which means that only enough projects can be planned that match the funding that is reasonably expected to arrive in those years. As federal and state infrastructure investment programs change and as local governments, non-profits and the private sector secure grant funding the regional pool of resources grows. In other words, projects and plans in the short, mid-term and long-range lists are priorities that the region can reasonably expect to achieve over the next 25 years.

The budget for projects and programs included in the Long-Range Transportation Plan was determined by referencing years 2022-2023 of the existing Transportation Improvement Program (TIP), years 2024-2036 of the 2025 Financial Guidance 12-year expenditure projections published by the Pennsylvania Department of Transportation, and years 2037-2050 projections of future funding at a 3% inflation rate. Even with nearly \$4.9 billion in anticipated funding, \$2,679,345,862 in unmet needs exist in the Lehigh Valley today.

## **Transportation Needs Assessment**

The Transportation Needs Assessment was a formal process for public outreach to municipalities and potential project sponsors, fulfilling State Long-Range Transportation Plan goals of extensive public and stakeholder involvement in project programming. The Lehigh Valley's expansive public engagement process included 24 meetings, between February 27 and March 24, with municipal officials, community leaders, residents and regional agency stakeholders in all 62 municipalities, to gather project requests and community priorities.

During the course of those 22 sub-regional public meetings and two regionwide public meetings, roughly 300 projects were submitted. They were added to the funded projects in the existing LRTP, and the current Transportation Improvement Program, as well as a lengthy list of previously submitted projects that could not be funded, titled the "unmet needs list." All together, it added to more than 600 projects.

The projects were then vetted to determine their eligibility for federal and state funding, using a complex evaluation model that used more than 40 data sets to determine everything from safety, to bridge conditions to proximity to underserved or disadvantaged communities, to how it would impact the environment. Setting priorities of which projects would be planned for potential funding was based on established federal and regional goals of safety, asset management, equity and environmental justice, freight movement and economic vitality, congestion reduction, and overall cost effectiveness, considering the available funding.

Ultimately, the LVTS held public workshops June 16, 23, 30 and August 3 to discuss every project and the scoring system to determine which projects would be funded and in what funding range.

## **Funding Categories**

The projects were put into 10 funding categories, and each category receives funding that can be used only for projects in that category.
